NOTICE OF RACE
Amended 10/18/24 1000

1. RULES

- 1.1. The regatta will be governed by the rules as defined in the Racing Rules of Sailing, including the ISSA Procedural Rules.
- 1.2. US Sailing prescription 63.2 is deleted.

2. SAILING INSTRUCTIONS

Sailing Instructions will be available on the official notice board by 0800 10/18/2024.

3. COMMUNICATION

- 3.1. The official notice board will be online at <https://scores.hssailing.org/>
- 3.2. The Race Committee will use a Telegram group to facilitate communications during the event. A link to join the group will be sent to coaches closer to the time of the event. The app is available for both apple and android devices. <https://telegram.org/> .

4. FORMAT

The event will consist of 2 separate fleets (420 and FJ), each divided into 2 divisions (A and B). Schools do not need to enter both fleets to be able to compete.

5. ELIGIBILITY

- 5.1. The event is open to all active NESSA teams.
- 5.2. 420 Fleet: Each team shall consist of at least four sailors, two skippers and two crews.
- 5.3. FJ Fleet: Each team shall consist of at least four sailors, two skippers and two crews, all of whom shall be either a Freshman (2028) or Sophomore (2027) unless permission from the OA.

6. ENTRY

- 6.1. The host school will receive two automatic entries in each fleet.
- 6.2. A maximum of 16 teams will be accepted on a first come first serve basis in the 420 Fleet.
- 6.3. A maximum of 6 teams will be accepted on a first come first serve basis in the FJ Fleet.
- 6.4. Schools may enter multiple teams in either fleet. However if the event is oversubscribed, all schools will be allowed one team before a second team from a school will be accepted.
- 6.5. Eligible teams can enter by completing the online entry form beginning September 16 at 1200, but no later than October 11, 2024. Entry Form: <https://forms.gle/hPGmZ83sDgKiD2mT8>
- 6.6. Competitors must be accompanied by a designated adult chaperone, who may be an advisor, coach, or parent.

7. FEES

There are no entry fees for this event.

7. RACE VENUE & COURSES

- 7.1. The racing area will be in Sippican Harbor.
- 7.2. The course will be chosen from those prescribed in ISSA Procedural Rule 7.7. Course diagrams will be provided in the sailing instructions.

8. SCORING

- 8.1. Each Fleet will be scored separately.
- 8.2. Scoring will be in accordance with ISSA Procedural Rules 9 and 11.

9. RIGHTS TO USE NAME AND LIKENESS

By participating in this event, competitors automatically grant to the Organizing Authority and the event sponsors the right, in perpetuity, to make, use and show, at their discretion, any photography, audio and video recordings, and other reproductions of them made at the venue or on the water from the time of their arrival at the venue, until their final departure, without compensation.

10. DISCLAIMER

Sailing is an activity that has an inherent risk of damage and injury. Competitors in this race participate entirely at their own risk. See RRS 3, Decision to Race. The race organizers (OA, Race Committee, Protest Committee, host club, sponsors, or any other organization or official) will not be responsible for damage to any boat or other property or the injury to any competitor, including death, sustained as a result of participation in this race. By participating in this race, each competitor agrees to release the race organizers from any and all liability associated with such competitor's participation in this event to the fullest extent permitted by law.
