

# NOTICE OF RACE

## 1. RULES

- 1.1 The regatta will be governed by the Racing Rules of Sailing (RRS), the ISSA Procedural Rules, the MISSA By-Laws and District Rules, this Notice of Race and the Sailing instructions. In the case of a conflict between the governing documents and the Sailing Instructions the latter shall take precedence.
- 1.2 In accordance with rule 70.5 (a), decisions of the protest committee are final. US Sailing's permission has been granted.
- 1.3 The organizing authority is the Midwest Interscholastic Sailing Association (MISSA), in conjunction with Community Sailing School.

## 2. ELIGIBILITY

1. Competing schools must be members of MISSA. This is a tier 2 fleet race regatta.
2. This is open to all MISSA Northeast high schools and is a closed qualifier. State Championship is MICHIGAN only.
3. Eligible schools may only enter one team. A team shall have no fewer than 4 sailors and no more than 8.
4. Sailors must be in grades 9 through 12.
5. No mixed teams.

## 3. REGISTRATION, ENTRY FEE & DEADLINE

- 3.1 The entry fee is \$60 per competitor. There will be lunch at this regatta, (snacks, and breakfast are not included.) You must have a refillable water bottle.
- 3.2 All Registrations will be online using the following and a link will be sent after you contact the organizer. [frikkerl@communitysailingschool.org](mailto:frikkerl@communitysailingschool.org). By entering this regatta, it serves as your waiver.

**3.3 Deadline for registration is September 19, 2025 by 1700.**

## 4. BOATS AND FORMAT

- 4.1 420 will be provided.
- 4.2 The Regatta will consist of A and B divisions of 420's Round-Robin format. Three races A and B constitutes a regatta.

- 6.1 Sailing Instructions will be posted on the white board at PYC and available via Techscore

## **7. VENUE and RACING AREA**

- 7.1 The venue will be on Cass Lake. Report to the Sailing Center, 3206 Orchard Lake for check in.

## **8. COURSES**

- 8.1 Based on conditions, the Race Committee will determine courses in accordance with the ISSA Procedural Rules (PR). Teams must provide a coach boat.

## **9. SCORING**

- 9.1 Scoring will be done in accordance with ISSA Procedural Rules

## **10. SUPPORT BOATS and COACHING**

- 10.1 No parents are allowed in the coach boats for spectating.

## **13. PRIZES**

- 13.1 State Championship awards will be awarded.

- 13.2 This is also a qualifier for the Great Lakes Championship in Chicago on October 25 and 26. 1<sup>st</sup> place – 4<sup>th</sup> earn a berth GLC. 5<sup>th</sup> - 7<sup>th</sup> place earn a berth to the Shepherd Regatta.

13.3 Advancing teams must notify the MISSA District Director and MISSA North East League Representative by noon on Tuesday following the regatta by noon.
