Sailing Instructions (SIs)

1 RULES

- 1.1 The regatta will be governed by the rules as defined in:
 - 1. The Racing Rules of Sailing (RRS).
 - 2. This Notice of Race (NOR).
 - 3. The Sailing Instructions (SI).
 - 4. The ISSA Procedural rules located at <https://hssailing.org/resources/rules/>
 - 5. The MISSA Supplemental rules located at <https://missa.hssailing.org/about/missa-district-rules>
- 1.2 In the event of a conflict between the governing documents and the Sailing Instructions, the SIs shall take precedence.
- 1.3 The Organizing Authority (OA) is the Midwest Interscholastic Sailing Association (MISSA). The Host Organization is Columbia Sailing School in conjunction with host schools: Jones College Prep, Lane Tech, Lincoln Park, U of C-Lab, and Whitney Young.
- 1.4 **[DP]** Drones usage will only be allowed subject to ISSA PR 5.2.
- 1.5 The US Sailing Prescriptions to Rule 63.1(b) and Preamble to Part 5, Section B shall not apply.
- 1.6 In addition to other rules changed in this document, the following rules are changed:
 - 1. RRS 60.4(a) adds, "(4) if the protest is by a boat and is based on a rule with the notation [NP]."
 - 2. RRS 60.5(c) adds, "(5) the protest is based on a rule with the notation [DP] and the protest committee decides the penalty shall be more or less than a single Disqualification."
 - 3. RRS 61.3 adds, "or is a request by a boat and is based on a rule with the notation [NP]."
 - 4. Rule 60.4(a)(2) is changed as follows: (2) if it alleges a breach of a rule of Part 2 or rule 31 and is from a boat that was not involved in, and did not see, the incident, or...

2 CHANGES TO SAILING INSTRUCTIONS

- 2.1 Official notices including changes to sailing instructions will be posted on the official notice board located at <https://scores.hssailing.org/f25/missa-shepherd/>
- 2.2 Any change to the sailing instructions will be posted:
 - 1. By 1800 on the day before a schedule change will take effect,
 - 2. Before 0900 on the day it will take effect or,
 - 3. In the event of AP posted ashore, no later than 15 minutes before AP is lowered ashore.
- 2.3 Changes to sailing instructions may be made on the water. Oral changes may be given on the water per RRS 90.2(c) using the following procedure:
 - 1. The signal boat will hoist Code Flag Lima (L) with one sound.

2. Boats shall come within hailing distance of the signal boat.
3. Oral changes will be made via VHF on channel 78 as a courtesy to coaches.
4. Any changes that will affect future races in the series will be posted once ashore.

3 COMMUNICATIONS WITH COMPETITORS

- 3.1 Notices to competitors will be posted on the official notice board online at <https://scores.hssailing.org/f25/missa-shepherd/>
- 3.2 On the water, the Race Committee intends to monitor and communicate with coaches via VHF radio on channel 78.
- 3.3 **[DP]** While racing, except in an emergency, a boat shall not make voice or data transmissions and shall not receive voice or data communication that is not available to all boats.
- 3.4 **[NP]** Errors and omissions in courtesy broadcasts are not grounds for a request for redress. ***This changes RRS 61.1(a) and 61.4(b)(1).***

4 CODE OF CONDUCT

- 4.1 **[DP]** Competitors, coaches, and support persons shall comply with reasonable requests from race officials.
- 4.2 The Columbia dock falls within a Zone of Play – only coaches, athletes, and race personnel are permitted in this area from the beginning of the Competitors Meeting on Saturday until the end of the Protest Filing Period on Sunday.
- 4.3 There will be a spectator exclusion zone of 100 yards around the racecourse. Spectators shall receive 1 warning upon entering this zone unless directed by a race official. A second entrance shall be cause for a protest by the OA against the individual/any affiliated team(s) under RRS 41 and RRS 60.
- 4.4 Spectator boats not belonging to Columbia Yacht Club members shall not dock on the Columbia Yacht Club dock. This is considered a Zone of Play under SI 4.2.

5 SIGNALS MADE ASHORE

- 5.1 Signals made ashore will be displayed on a staff at the entrance to the club ship near the dock.
- 5.2 When flag AP is displayed ashore, '1 minute' is replaced with 'not less than 30 minutes' in Race Signals AP.
- 5.3 **[DP]** Competitors in boats shall not leave the docks before a Race Committee vessel or CYC safety vessel.

6 SCHEDULE OF RACES

7 RACING AREA

The racing area will be either inside Monroe Harbor, or the open waters of Lake Michigan, east of the Monroe Harbor entrance as announced by the RC at the day's competitors meeting.

8 COURSES AND MARKS

- 8.1 Courses will be in accordance with ISSA PR 7.8. A trapezoid course may be used.
- 8.2 The Race Committee may designate course selection orally.
- 8.3 Marks will be drop or robotic marks.
- 8.4 In accordance with ISSA PR 7.8(c) after the starting signal, the Race Committee may change the position of any mark to maintain course configuration, provided that no boat is on that leg of the course. No signals are required. ***This changes RRS 33.***
- 8.5 The diagram in SI Addendum A shows the courses, including the approximate angles between legs, the order in which marks are to be passed, and the side on which each mark is to be left.
- 8.6 For courses WA2, LA2 and WA3, Mark 1 may have an offset. If the offset is not in place, the single windward mark shall be left to port. Mark 2 will be a gate. If the gate is not in place, the single leeward Mark 2 shall be left to port.
- 8.7 For Trapezoid courses, Marks 3 and 4 will be a gate. If the gate is not in place, the single leeward mark shall be left to port.
- 8.8 Routine movement of robotic marks will not be grounds for redress. This changes RRS 61.4(b)(1). Routine movement includes marks maintaining the intended location and returning to station after having been moved away by a boat.

9 THE START, FINISH AND RECALLS:

- 9.1 Races will start in accordance with ISSA PR 7.9(a).
- 9.2 This regatta is being run in conjunction with the Great Lakes Championship Regatta hosted by Chicago Yacht Club.
- 9.3 The Columbia Yacht Club Burgee will be used as the signal to designate a starting sequence for the Shepherd Championship Division is about to start. The Chicago Yacht Club Burgee will be used as the signal to designate a starting sequence for the Great Lakes Division is about to start. Either burgee can also be used as a class flag with another Race Signal to designate the flag only applies to a single Championship Division.

- 9.4 **[DP]** Boats whose warning signal has not been made shall avoid the starting area during the starting sequence for other races.
- 9.5 RRS US Sailing Prescription Appendix U - Sound-Signal Starting System shall be used.
- 9.6 The starting line is between a staff displaying an orange flag on the signal vessel at the starboard end and the course side of the port-end starting mark.
- 9.7 Individual recalls will be made in accordance with ISSA PR 7.9(b).
- 9.8 General recalls will be signaled by a series of short sounds. After a general recall, RRS 30.1 shall apply except Flag I (India) need not be displayed in accordance with ISSA PR 7.9(c). ***This changes RRS 30.1.***
- 9.9 The finishing line is between a staff displaying a Blue flag on the finish vessel and the course side of the nearby finishing mark.

10 BREAKDOWNS

- 10.1 Breakdown requests shall be filed in the same manner as protests.
- 10.2 Breakdowns shall be scored in accordance with ISSA PR 9(e).
- 10.3 Compensation shall be consistent with ISSA PR Appendix 5.

11 PROTESTS & HEARING REQUESTS

- 11.1 Protest procedure will be in accordance ISSA PR Part VI - 15.
- 11.2 Per ISSA PR 8(b), competitors shall not communicate with a coach before reporting to the Race Committee their intent to protest.
- 11.3 Protests and requests for redress shall be filed in person at on the rail deck with the Jury Secretary within the appropriate time limit.
- 11.4 A boat's protest time limit is 30 minutes after the Signal Vessel returns to the dock.
- 11.5 Hearings will be held in person at Chicago Yacht Club - Monroe Station. A boat shuttle MAY be available to transport competitors from Columbia Yacht Club to Monroe Station.

12 SCORING

- 12.1 The scoring system is as follows: Scoring will be in accordance with ISSA PR 9.
- 12.2 Three (3) races in each division are required to be completed to constitute a regatta.

13 SAFETY

- 13.1 Competitors shall wear USCG approved life jackets as outlined in ISSA PR 2.2.
- 13.2 **[DP]** A boat that retires from a race shall notify the Race Committee either before leaving the course, or if that is impossible, immediately after arriving ashore.

14 FORMAT

- 14.1 The Race Committee will attempt to complete a full rotation.
- 14.2 Rotation schedules and boat assignments will be posted on Tech Score.

15 [DP] SUPPORT TEAMS AND COACHING

- 15.1 Team leaders, coaches, and other support personnel shall stay outside areas where boats are racing from the time of the preparatory signal to the start until all boats have finished or retired or the Race Committee signals a postponement, general recall, or abandonment.
- 15.2 Coaching may take place below the finish line. All coaches shall assist when and where necessary for safety or at the request of the Race Committee. Failure to do so may result in exclusion from the racecourse.

16 SPECIAL CLOTHING

- 16.1 Special clothing requirements:
 - 16.1.1 All competitors shall provide their own dry suit and have it on hand at the venue on each day of racing as per ISSA PR 2.3.
 - 16.1.2 **[NP]** On each day of racing, the OA will announce whether dry suits will be required to be worn by competitors racing on that day.
 - 16.1.3 If the air temperature plus the water temperature equals or exceeds 100 degrees Fahrenheit, dry suits will only be required to be worn by the OA on that day in exceptional circumstances.
 - 16.1.4 Competitor's failure to wear a dry suit while racing on a day where dry suits are required by the OA will be scored DSQ by the RC without a hearing. ***This changes RRS 63.1.***

17 RISK STATEMENT

Competitors participate in the regatta entirely at their own risk. See RRS 3, Decision to Race. The organizing authority will not accept any liability for material damage, personal injury, or death sustained in conjunction with or prior to, during, or after the regatta.

17 PRIZES

Prizes will be awarded to schools placing 1st, 2nd, and 3rd overall.

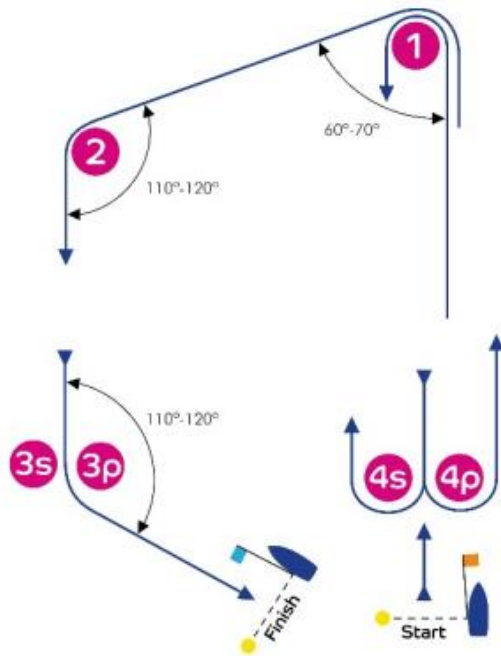
Addendum A Courses

WA3	Start-1-1a-2s/2p-1-1a-2s/2pUpwind Finish



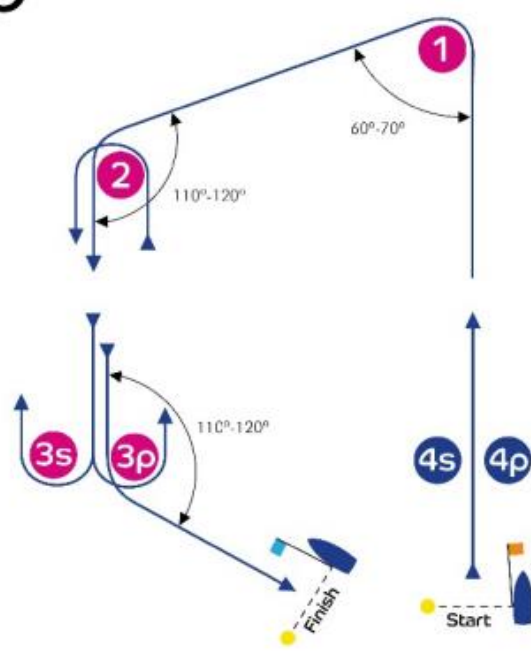
