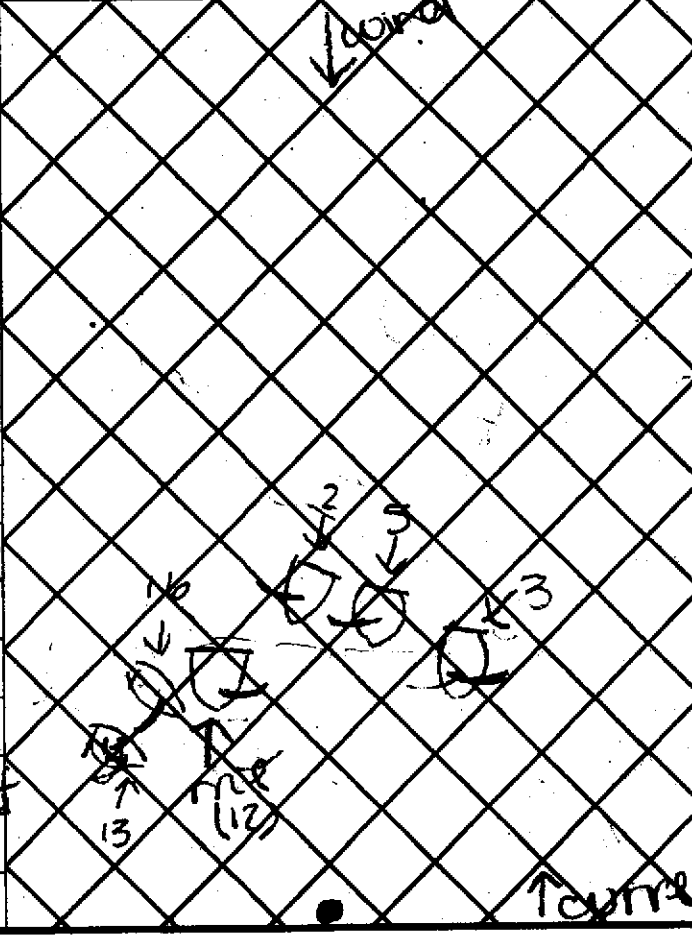

I avoided as best as I could and yelled protest, then the port tack boats to the left of me (boats 2 & 5) ran into my stern to then make me capsize. Boat 2 was the only boat that did turn S. Boat 3 is my witness.
