



**2017 USSCMC Crossroads Regatta  
February 11, 2017**

**NOTICE OF RACE**



**HOST: Crossroads Yacht Club & USSCMC**

**SITE: US SAILING Center, Martin County, 1955 NE Indian River Dr., Jensen Beach, FL 34957**

**1. RULES**

This regatta will be governed by the current ISSA Procedural Rules and SAISA Supplementary Rules, *The Racing Rules of Sailing*, the prescriptions of US SAILING, this Notice of Race, and the Sailing Instructions.

**2. SCHEDULE OF RACES**

Saturday, February 11

0900 Arrival and check-in, boat rigging  
0930 Competitors' meeting  
1000 Start of first race of the day  
Cookout to follow the day of racing

Sunday, February 12 (Make-Up Date)

**3. FORMAT**

- 3.1 This will be a single-division regatta; teams will rotate through the boats per a rotation posted on the day of the event.
- 3.2 One race constitutes a series
- 3.3 If racing is not able to take place on February 11, schools should be prepared to race on Sunday February 12.
- 3.4 A Sound Signal Starting System shall be used.
- 3.5 Time permitting; the Race Committee will run a series of multiple short races, with boat rotations as set forth at the skipper's meeting. It shall be the goal of the race committee to complete as many races as possible for the day of racing.
- 3.6. All coaching, including instruction, assistance, equipment or sustenance shall be provided only on shore or on a designated vessel on the water (if equal access can be provided).

**4. SCORING**

- 4.1 Low point system for individual races as modified by ISSA Rule 9 will be used. Ties will be resolved per procedural rule 11(c).
- 4.2 Protest hearings, if any, may take place between races. We will attempt to post preliminary results in real time between races.

**5. AWARDS**

Prizes will be awarded for the top 3 finishers for the series. The awards ceremony will take place during the post racing cookout.

## **6. FEES**

There will be \$15 entry fee per team for this event. Registration may be found by visiting the upcoming regattas page at [www.usssmc.org](http://www.usssmc.org). If you should have any difficulties accessing the registration page, please call (772)334-8085. Each competitor must have waivers signed for both SAISA and the USSCMC.

**Registration Deadline:** All participating teams must pre-register by Thursday February 9 for this event.

## **7. ELIGIBILITY**

7.1 Sailors must be attending High School, grades 8 – 12

7.2 A team must represent one school and consist of a no fewer than 2 sailors. Teams with more than 3 sailors must contact the regatta organizer.

7.3 A single school may be represented by more than one team, with regatta organizers approval.

7.4 This event is meant to be for sailors who have not otherwise had a chance to represent their team at another varsity event during the 2016/2017 Season. Sailors who have attended SAISA varsity events in the role of skipper, are welcome to attend in the role of crew. Sailors who have attended SAISA varsity events crew, are encouraged to attend in the role of skipper.

7.5 Registration is on a first paid/first allowed basis. Once 13 teams have registered, each team after the 13th will be notified by the venue that their entry shall be contingent upon their ability to bring their own 420 sailboat to add to the rotation.

7.6 An adult school representative/advisor is required to accompany each team and be responsible for their conduct on and off the water. The team representative, who may be an advisor, coach, or parent, is expected to have full authority to obtain medical treatment for his team members and have the ability to monitor his/her teams' experience in their ability to sail in varied conditions as may be encountered.

## **8. SAILING INSTRUCTIONS**

Sailing Instructions will be available upon check-in.

## **9. BOATS**

Club 420's will be used but will not utilize the spinnaker or trapeze, and 13 boats will be provided by the venue. Personal safety equipment including US Coast Guard Type III PFDs must be furnished by the competitors.

## **10. RACING AREA**

Racing will be on the Indian River, east of the Sailing Center.

## **11. LUNCHEAS AND DINNER**

Plan to bring your own snacks, lunch and **water bottle**. There will be a hamburger and hotdog cook out at the conclusion of racing on Saturday free to all competitors and coaches. For all non-competitors a \$5 donation is suggested per person. Drinks are not included. Please bring a sufficient amount of water for the entire day. Water fountains and large water coolers will be available to fill reusable drink containers.

## **12. DAMAGE**

Damage that requires more than normal maintenance is considered a serious incident. If the Regatta Chairman determines that reasonable care was not used and resulted in damage one or both boats may be

disqualified regardless of any alternative penalties already taken. In extreme cases, the skipper and crew of one or both boats may be excluded from the rest of the regatta and held financially responsible for the damages. Due to varied conditions that may be encountered, and the skill level of individual sailors and teams, it is the advisors decision to sail and participate and their Decision to Race.

### **13. DIRECTIONS**

#### **13.1 From I-95 Southbound**

1. Take exit 100 for .3 miles to FL-714 E.
2. Turn left onto FL-714 E for 5.6 miles. (cross 72<sup>nd</sup> Ave, SW Boatramp Ave and SW Citrus Blvd)
3. Turn left onto SW Martin Downs Blvd for 2.8 miles. (SW Martin Downs becomes SE Monterey/714 after crossing the Palm City Bridge) (cross High Meadows Ave, Mapp Rd, Palm City Bridge, Kanner Hwy. Keep in left lane after Kanner Hwy as SE Monterey veers to left just after the Sheriff's office).
4. Continue 2.1 miles on FL-714 E/SE Monterey Rd (crossing US 1/SE Federal Hwy, railroad tracks, SE Dixie Hwy and passing YMCA on left).
5. Turn right onto A1A N/SE Ocean Blvd. Drive 1.6 miles (crossing Evans Crary Bridge over St. Lucie River – stay in left lane on bridge and in left turning lane just before N Sewall's Point Rd).
6. Turn left onto N Sewall's Point Rd. Drive 1.6 miles (passing Dolphin Bar and Shrimp House on right).
7. N Sewall's Point Rd becomes NE Indian River Dr at Palmer St. blinking light. Continue on NE Indian River Dr .5 miles (passing Indian RiverSide Park entrance on right) to US Sailing Center – 1955 NE Indian River Dr. (2-story yellow building on right).

#### **13.2 From I-95 Northbound**

1. Take exit 101 to merge onto FL-76-E/Kanner Hwy toward Stuart. Drive 4.7 miles (passing Cove Rd, Salerno Rd, Indian St and Martin County High School on the right).
2. Turn right onto FL-714E/SE Monterey Rd. Drive 2.9 miles (crossing US 1/SE Federal Hwy, railroad tracks, SE Dixie Hwy and passing YMCA on left) to A1A N/SE Ocean Blvd.
3. Follow #5 – 7 above.

#### **13.3 From Florida's Turnpike**

1. Take exit 133 SW Martin Downs Blvd in Palm City. Drive 6.6 miles to A1A N/SE Ocean Blvd.
2. Follow #5 – 7 above.

## **16. CONDUCT**

No contestant shall use, either on or off the water, alcoholic beverages (beer, wine, or distilled spirits, each as defined in Chapter 51 of the US Internal Revenue Code and intended for beverage use), or marijuana, cocaine, or any other controlled substance (as defined in 21 US Code 802), the possession of which, by that contestant is unlawful under 21 US Code 841. Infringements of this regulation and/or other inappropriate conduct occurring during this event, may be the basis for a hearing under RRS 69.1. The protest committee for such a hearing shall include a member of the ISSA Board of Directors, the Chief Umpire of the event, and at least one other person. This protest committee shall, at a time and place selected by it, meet to hear said protest, and it may impose scoring penalties, or other sanctions that it deems appropriate, including summary removal from the regatta.

## **17. DISCLAIMER OF LIABILITY**

Competitors participate in the regatta entirely at their own risk. See RRS 4, Decision to Race. The organizing authority and host will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.
