Notice of Race (NOR)

1 RULES

- 1.1 The event is governed by the rules as defined in *The Racing Rules of Sailing*.
- 1.2 RRS Appendix D: Team Racing Rules will be in effect.
- 1.3 The ISSA Procedural Rules 2021-2024 available at <https://hssailing.org/documents/ISSA-PR-2021-2024.pdf> apply.
- 1.4 The MISSA Supplemental Rules available at <https://missa.hssailing.org/about/missa-district-rules> apply.

2 Umpired Races

- 2.1 Races will be umpired by one coach from each participating team. These umpires will operate separate power boats.
- 2.2 If either team cannot provide a coach to umpire, the racer will be handled by a single umpire. Teams must provide a coach boat for their coach.

3 SAILING INSTRUCTIONS

- 3.1 The sailing instructions will be available by 6pm on Friday May 14th.

4 COMMUNICATION

- 4.2 On the water, the race committee will make courtesy broadcasts to competitors & coaches on VHF 71.

5 ELIGIBILITY AND ENTRY

5.1 This event is a MISSA Tier 3 regatta, open to MISSA West teams in good standing.

5.2 Boats may enter the event by registering online click here missa.hssailing.org

5.3 To be considered an entry in the event, a boat shall complete all registration requirements and pay all fees by 1700 on Friday May 14th.

5.5 Entry will be limited to 12 teams.

6 FEES

6.1 Entry fees are as follows: \$40 per team

6.2 Lunch will NOT be provided.

7 SCHEDULE

7.1 The scheduled time of the warning signal for the first race is 0900.

7.2 On the last scheduled day of racing no warning signal will be made after 1500.

8 COURSES

8.1 Courses will be set and sailed in accordance to the recommendations set forth in the ISSA Procedural Rules 2021-2024. Any changes will be noted in the Sailing Instructions.

9 SCORING

9.1 A minimum of three races in each division is required for a regatta to be scored.

9.2 A boat's series score shall be the total of her race scores, in accordance with ISSA PR.

10 SUPPORT PERSON VESSELS

10.1 Support vessels shall keep clear of the race course and only coach from the SI designated area between races.

11 RISK STATEMENT

11.1 RRS 3 states: ‘The responsibility for a boat’s decision to participate in a race or to continue to race is hers alone.’ By participating in this event each competitor agrees and acknowledges that sailing is a potentially dangerous activity with inherent risks. These risks include strong winds and rough seas, sudden changes in weather, failure of equipment, boat handling errors, poor seamanship by other boats, loss of balance on an unstable platform and fatigue resulting in increased risk of injury. **Inherent in the sport of sailing is the risk of permanent, catastrophic injury or death by drowning, trauma, hypothermia or other causes.**

12 COVID-19

12.1 The sailing instructions may specify additional ISSA PR changes that affect the schedule, including (but not limited to): limiting equipment rotations, limiting sailor rotations between divisions, scheduling divisions during separate times, or sailing both divisions concurrently on the water.

12.2 Health screenings may be required before entering the regatta host’s site.
