1 ORGANIZING AUTHORITY

The Organizing Authority (OA) is the Pacific Coast Interscholastic Sailing Association (PCISA), together with Treasure Island Sailing Center.

2 RULES

2.1 The regattas will be governed by the rules as defined in The Racing Rules of Sailing, as modified by the current ISSA and PCISA Procedural Rules, the Notice of Series, this Notice of Race for each Event, and the Sailing Instructions for each regatta.

3 ELIGIBILITY AND FORMAT

Eligibility is governed by the NorCal One-Day Notice of Series.

4 ENTRY AND REGISTRATION

4.1 Entry and Registration is governed by the NorCal One-Day Notice of Series.

4.2 **These two regattas have a maximum of 60 entries each.** If there are more than 60 entries, PCISA will decline entries in the following order: Teams using borrowed sailors; and then one team from each school with the largest number of entries, repeated until the total number of entries is below 60. Teams will be notified of their entry status as soon as possible after the entry deadline.

7 Directions, Trailers & Parking

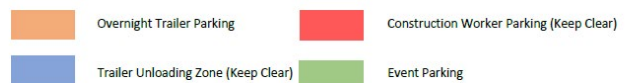
Directions: Entering "Treasure Island Sailing Center" in Waze/Apple/Google/Maps will only work to get you onto Treasure Island. Due to constantly changing road closures and detours for construction, expect the apps won't work, and you will need to make a large circle around the Island to get to TISC on the end of Clipper Cove. It is possible there will be new detours since these directions were written:

- After taking the exit to Treasure Island proceed down the causeway onto Avenue of the Palms,
- Turn right onto 9th Street when Avenue of the Palms dead ends,
- Proceed on 9th Street until you reach Avenue M,
- Turn right onto Avenue M,
- Proceed down Avenue M for one block until you reach 8th Street (at the baseball field),
- Proceed down 8th Street until you reach Avenue N (on the waterfront),
- Turn right onto Avenue N and proceed all way down the waterfront until you reach the Treasure Island Sailing Center

Trailers (see image):

- Trailers are to be unloaded in the near vicinity of the dinghy entrance gate just West of the TISC office buildings
- Trailer Parking is available outside the TISC gate on the west most side of the facility. Past the dinghy entrance gate and to the left
- **If you plan on dropping off trailers Friday night you MUST contact TISC beforehand. Direct inquires to hunter.cutting@tisailing.org**

Parking (see image): Event parking is available along the outside gate of the TISC facility and along Building 3 (behind dinghy entrance gate). DO NOT PARK along the chain-link fence in front of the construction site OR in front of the rolling door of Building 3
