


Invitational JV Fleet Race

NOTICE OF RACE

1. RULES

- 1.1. The regatta will be governed by the *rules* as defined in the Racing Rules of Sailing, including the ISSA Procedural Rules.
- 1.2. In accordance with RRS 70.5(a), decisions of the protest committee are final. US SAILING's permission has been granted.

2. SAILING INSTRUCTIONS

Sailing Instructions will be available on the official notice board.

3. COMMUNICATION

The official notice board will be online at https://scores.hssailing.org/

4. ELIGIBILITY AND ENTRY

- 4.1. The regatta is open to NESSA and non-NESSA teams (conglomerate teams or out of district school teams).
- 4.2. Competitors must be accompanied by a designated adult chaperone, who may be an advisor, coach, or parent.
- 4.3. A maximum of 18 teams will be accepted on a first come first serve basis.
- 4.4. Each team shall consist of at least four sailors, two skippers and two crews, all of whom should be JV or lower Varsity roster sailors, coaches should use their own discretion.
- 4.5. Schools may enter multiple teams. However if the event is oversubscribed, all schools will be allowed one team before a second team from a school will be accepted.
- 4.6. Eligible teams can enter by completing the online entry form no later than May 15th, 2024. Entry Form: https://forms.gle/mJ9CFn36zMumZF6U9

- 7.1. The racing area will be in or near Sippican Harbor.
- 7.2. The course will be chosen from those prescribed in ISSA Procedural Rule 7.7. Course diagrams will be provided in the sailing instructions.

8. SCORING

Scoring will be in accordance with ISSA Procedural Rule 9.

9. RIGHTS TO USE NAME AND LIKENESS

By participating in this event, competitors automatically grant to the Organizing Authority and the event sponsors the right, in perpetuity, to make, use and show, at their discretion, any photography, audio and video recordings, and other reproductions of them made at the venue or on the water from the time of their arrival at the venue, until their final departure, without compensation.

10. DISCLAIMER

Sailing is an activity that has an inherent risk of damage and injury. Competitors in this race participate entirely at their own risk. See RRS 3, Decision to Race. The race organizers (OA, Race Committee, Protest Committee, host club, sponsors, or any other organization or official) will not be responsible for damage to any boat or other property or the injury to any competitor, including death, sustained as a result of participation in this race. By participating in this race, each competitor agrees to release the race organizers from any and all liability associated with such competitor's participation in this event to the fullest extent permitted by law.
